## Background to the STAR project

The STAR project (*Support Training Activities on the data protection Reform*) is providing support to the training activities of European Union (EU) Data Protection Authorities (DPAs) and data protection officers (DPOs) on the EU data protection reform, especially the General Data Protection Regulation (GDPR).

The GDPR requires these two categories of data protection actors to undertake training activities (Arts 57(1) and 39(1)(b)). Each DPA developing such materials in isolation increases the overall cost, risks undermining the harmonising effect of the GDPR and puts greater pressure on its consistency mechanisms. STAR will thus provide them with necessary and efficient training materials and resources. In particular, STAR will:

- 1) formulate the training topics in close cooperation with stakeholders,
- 2) author the actual training materials,
- 3) validate and test them in pilot trainings.

This output will be freely and publicly available in English in a digital form. STAR is directly addressed to EU DPAs and DPOs; it also offers a benefit to other privacy and data protection professionals in the EU and beyond. The STAR consortium will encourage stakeholders to translate the materials, where appropriate, to tailor them to the audience mother tongue, and will kindly ask stakeholders to allow the translated materials to be published on the project's website in a spirit of European cooperation and to foster the effectiveness of STAR.

STAR supports the legal obligations of DPAs and DPOs to undertake training activities and, in order to facilitate their work, will provide them with ready-made, easy-to-customise and easy-to-run training materials, easily adaptable to specific training situations. STAR will also provide to the European Data Protection Board (EDPB) the common training programmes (Art 70 GDPR). The main outputs are thus the training materials and resources themselves. While their exact format and nature will be refined in cooperation with stakeholders, the following will at least be included:

- 1) Training scenarios for each training category,
- 2) A Seminars' Topics List, based on the training scenarios,
- 3) Seminar Material for each one of the seminars,
- 4) Webinars (selected from the Seminars' Topics List),
- 5) A training Handbook,
- 6) A takeaway reference GDPR checklist,
- 7) A ten-point GDPR introductory list.

## Executive summary

The purpose of this contact list is to support the development, validation and dissemination of the training materials developed in the STAR project. Collecting data in a scientifically-planned and consistent way is of key importance in order to build a dataset that proves effective in order to achieve such a purpose.

This stakeholder contact-list has been built in a few, pondered steps. First, we identified key industries for which the impact of the GDPR is to be considered greater. We selected Automotive, Financial, Healthcare/Pharma, Technology, Legal, Marketing, Media & Telecommunications, Non-profit, Security, and Transportation sectors.

Second, for each Member State, we selected several companies per sector. By selecting each company, we avoided (as much as possible) companies that are a branch of a multinational company, due to the fact that in those companies GDPR-training will be carried out following the mother company's indications. At the same time, we considered important to select companies of reasonable size and/or companies that are known to manage data on a larger scale, due to the fact that data processing by said company has a greater impact on society.

After careful consideration, we decided to focus in collecting general email addresses, such as `privacy@examplecorporation.com` or `dpo@examplecorporation.com`, and not to include personal work email addresses, such as `john.smith@examplecorporation.com`, for two reasons. First, personal work email addresses have a limited life duration: especially in the data protection environment, turnover is fast, and people move from organisation to organisation in a relatively short time frame: as a consequence, we consider general addresses to be more reliable for the purposes of the project, i.e. to contact a selected number of these organisations at a later stage for the activities under Work Streams 3 and 4, as well as for dissemination purposes in the final months of the project. Second, while many contacts are available online and their processing may be potentially carried out based on legitimate interest ex Article 6 GDPR, other were obtained through existing relationships, and we do not believe the data processing consent we obtained extends to a transfer to third parties, even for audit purposes.

By choosing general email addresses, we both obtained reliable contacts and can freely transfer this data to the European Commission for evaluation purposes.

Two annotations shall be made with regard to the collected data concerning stakeholders. First, the availability of a direct, dedicated data protection contact is largely inconsistent in the European Union. While stakeholders in a few Member States, possibly due to more stricter pre-GDPR rules, always provide for a dedicated email address or telephone number, the landscape in other Member States is different, with several companies lacking even a simple Privacy Notice on their websites. This limited the possibility for the consortium to obtain a homogeneous number of contacts in each Member State. Two additional reasons for this imbalance are: a) linguistic barriers that make it extremely difficult to obtain data in a few Member States, sometimes also due to the limited translation of websites into English or other EU commonly-spoken languages; b) the scattered use of contact forms rather than providing email addresses.

Despite these difficulties, the consortium obtained almost 250 contacts between DPAs and other stakeholders, in line with the project commitments and perfectly adequate for the stakeholder engagement activities that will follow later on in the project.

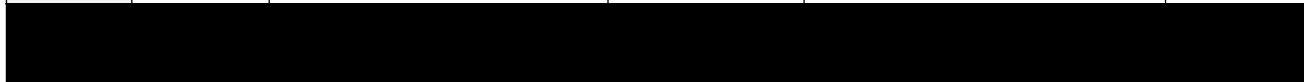

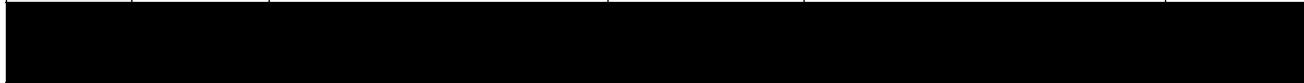

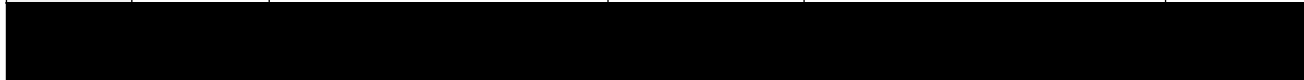
